## Ally That's a "Savings" Bucket Sweepstakes Official Rules

4. Winner Notification: Potential winner will be notified by e-mail/phone on or about May 16, 2025. Failure to respond to the initial notification within twenty-four (24) hours after transmission to potential winner or return of notification as undeliverable after two (2) attempts will result in disqualification and award of the prize to an alternate winner (time permitting). Potential winner will be required to complete, sign and return within forty-eight (48) hours of transmission, an Affidavit of Eligibility, a Liability Release and Indemnification, and a Publicity Release, where allowed by law and the necessary paperwork for a background check ("Prize Documents").
